Creative Edge Travel, LLC

Group Sales Agreement

Date of Effect: 11/05/2025

1. Parties

This agreement is entered into by and between Creative Edge Travel LLC ("Company," "We," "Us," "Our") and you, the Client ("Client," "You," "Yours"). It applies to group trip bookings and services for clients joining a pre-arranged group tour open to the public. By purchasing a Tour ("Tour") with Creative Edge Travel ("CET") you agree that you have read, understood, and agree to this agreement. You must not accept a booking with CET unless you agree to these terms and conditions. The services to be provided are those referred to in your emailed booking confirmations (collectively, your "Confirmations").

A. **Electronic Signatures and Acceptance:** This Agreement may be executed electronically, and electronic signatures shall be deemed valid and binding. Your electronic acceptance, payment of deposit, or participation in the tour constitutes your agreement to be bound by these terms and conditions as if you had physically signed this document.

2. Passport and visas

- A. You must have and bring with you a valid passport and have obtained all of the appropriate visas, permits and certificates for the countries which you will visit during your CET Tour.
- B. Your passport must be valid and not expire for 6 months beyond the departure date of the international flight you are taking to begin your Tour, and with a minimum of 2 blank passport pages available.
- C. It is your responsibility to ensure that you are in possession of any correct visas, permits and/or certificates for your trip. We are not responsible if you are refused entry to any country or region because you lack the correct passport, visa or other travel documentation needed for your departure/return, nor will you be entitled to any refund from CET. Once you begin your Tour, should you lose or have your passport stolen, and/or any visa or travel documentation that prevents

you from participating in the remainder of the Tour, you will not be entitled to a refund of any kind from CET.

3. Age & Health requirements

You and all members of your group must be at least 18 years old and have reached the age of majority in your jurisdiction of residence at the time of registration to both book (pay for your CET Tour) and travel with us. Any group members under the legal age of majority in your jurisdiction of residence at the time of registration must be accompanied by an adult at all times. It is your responsibility to ensure that you are in healthy physical condition to allow full participation in the trip and to obtain proper and detailed medical advice for the latest health requirements and recommendations for your destination. If you do not do so and are either not allowed to enter any country by direction of any government/immigration entity, or suffer personal injury as a result, we have no liability to you of any kind for any loss, injury, or damage which you may suffer. You warrant that you are physically and mentally able to participate in the Tour and that you currently have no known or suspected physical or mental condition which would impair your ability to participate in the Tour or which could be aggravated as a result of the Tour.

4. Required information

- A. To enable us to confirm your CET Tour arrangements, you must provide all requested details. Necessary details vary by Tour, and include but are not limited to your full name listed on your government issued passport, date of birth, nationality, passport number, passport issue and expiry date and any pre-existing medical conditions you have which may affect your ability to complete your travel arrangements. On some more demanding Tours we may also require you to complete and forward a Self-Assessment form. Failure to provide requested details may result in additional charges or non-refundable cancellation of your Tour at CET's election.
- B. You agree to provide CET with a scan of your Passport that must be emailed to CET within sixty (60) days of the commencement of the Tour. Failure to provide this scan timely shall result in a \$25/per day late presentation charge, and if not provided within thirty (30) days prior to the commencement of your Tour, you will not be able to participate in the Tour, nor will you be entitled to a refund- in this instance, you may only apply the full cost you paid for your CET Tour as a credit toward a future CET Tour to be used within one year. Beyond one year, your

credit cash value will diminish by 20% for each additional month that the credit is not applied.

- C. Your passport must also be presented to the CET Tour Leader at the beginning of the CET Tour to verify your identity. Failure to present your Passport for identification purposes means you will not be able to join the CET Tour, and you will not be entitled to a refund (in whole or in part).
- D. CET will request knowledge regarding any dietary restrictions/allergies you may have in doing so CET will make reasonable efforts to try to accommodate the dietary restrictions/allergies you may have, but you expressly agree that you fully assume the risk for any and all food or drink consumed during the Tour and that CET will assume no risk, whether casual, negligent, or grossly negligent, with respect to your dietary restrictions/allergies in any way possible.

5. Travel Insurance

Travel insurance is mandatory for all CET clients and should be taken out ninety (90) days prior to the commencement of your Tour, or otherwise as soon as possible after you have purchased your Tour with us. Your travel insurance must provide cover against personal injury, death, medical expenses, emergency medical treatment, repatriation, and evacuation expenses at a minimum coverage of \$100,000 USD. We also strongly recommend it covers cancellation for ANY reason and loss of luggage. You agree that you must email CET proof of your travel insurance ninety (90) days prior to the commencement of your CET Tour. You will be unable to join the CET Tour without it, and you will not be entitled to a refund (in whole or in part) for any purposeful or inadvertent ability of providing proof.

6. What's included in your CET Tour

- 1. All accommodations listed in your emailed itinerary
- 2. All transport listed in your emailed itinerary
- 3. Sightseeing and meals as listed in your emailed itinerary
- 4. The services of a group leader as described in your emailed itinerary
- 5. What is further detailed in your emailed itinerary

7. What's not included in your CET Tour

- 1. International or internal flights unless specified in your emailed itinerary
- 2. Airport transfers, taxes and excess baggage charges unless specified in your emailed itinerary
- 3. Meals other than those specified in your emailed itinerary
- 4. Visa and passport fees
- 5. Mandatory Travel insurance
- 6. Optional activities and all personal expenses
- 7. Some locations might not include the cost of air conditioning or heat and you will be charged according to use
- 8. Personal protective equipment such as masks, gloves, and hand sanitizer
- 9. Optional tips for your guides, drivers, local hosts, and other staff
- 10. Any service not specifically listed as "included" above in Section 6 or any service not specified in your emailed itinerary
- 11. Extra charges necessary to transport your luggage due to not following the luggage allowance guidelines provided in your post-booking emails or documents

8. Fees

CET Tour fees are subject to variable and seasonal pricing, both of which are standard practice within the travel industry. This means that our Tour prices may vary at any time in accordance with demand, market conditions and availability. It is likely that different passengers on the same trip have been charged different prices. Your best option if you like the price you see is to book at that time. Any reduced pricing or discounts that may become available after you have paid your deposit will not apply. If you wish to cancel your booking to take advantage of a cheaper price, full cancellation conditions apply. Note that prices may vary depending on which currency the booking is made. Please also note that certain additional charges ("Additional Charges") may apply during the Tour for things such as AC/Heating in your accommodation, or other items other incidental needs for your accommodations during the Tour. In all instances it is your responsibility to pay for these Additional Charges, unless CET elects at any time (at its sole discretion) to cover these charges.

Payment schedules and deadlines will be specified in your booking confirmation. Late payments may incur a fee of \$25 per day until payment is received in full. Failure to make payments according to the agreed schedule may result in cancellation of your booking with applicable cancellation fees applied per Section 11.

9. Optional Activities

Optional activities not included in the Tour price do not form part of the trip or this contract. You accept that any assistance given by your group leader or local

representative in arranging optional activities does not render us liable for them in any way. The contract for the provision of any optional activity will be between you and the activity provider.

10. Cancellation by us

- A. If we are forced to cancel your CET Tour, or any CET Tour at any time, we may do so without any liability whatsoever, up to ninety (90) days before departure. In doing so you will receive a full cash refund.
- B. We may also cancel your CET Tour without any liability whatsoever at any time prior to departure if, due to terrorism, epidemics, natural disasters, political instability or other external events it is not viable for us to operate the planned itinerary. If we cancel your CET Tour under either of these circumstances, at our sole discretion you can receive credit for any amounts paid which can be applied to an alternate departure date within 12 months from the date of your original trip departure. In circumstances where the cancellation by CET is due to external events outside of our reasonable control, refunds will be less any unrecoverable costs that you may have incurred as a result of your booking including but not limited to visas, vaccinations, travel insurance excess or non-refundable flights.
- C. If you are asked to leave a tour for bad behavior, violence, or any other disruptive action, you will not be refunded.

Please note that CET will not refund any payments until we have received refund monies from

applicable suppliers. This can sometimes take up to sixteen (16) weeks or more, and in some

cases we may not be able to recover costs from certain partners depending on their own

cancellation policy. CET has no special knowledge of suppliers' financial condition and no liability for supplier defaults or for recommending future travel credits with suppliers that may be out of business by the time the client tries to use the credits. CET will assist with obtaining any refunds due or rebooking trips using future credits, but CET will charge a nonrefundable fee of \$250 for such services.

11. Cancellation by You & Refund Policy

CET incurs costs months before you book your tour. Thus, we must keep policies that allow us to continue offering the unique and immersive journeys you crave. However,

we also understand that it can feel intimidating to make the decision to book an international tour which is why we offer a 48-hour refund guarantee on your deposit. You can book with confidence knowing you'll have 48 hours to double down on that decision or change your mind. If you do change your mind and let us know you'd like to cancel within 48 hours of your initial deposit, we will send you a full cash refund. Cancellations within the 48-hour window must be sent in writing to sierra@creativeedgetravel.com within 48 hours of your initial deposit payment. 48 hours after the time of your initial deposit, your deposit will become non-refundable and the following policies will apply.

If you cancel 90 days or more before your tour departure date, the deposit and any other payments can be converted into credit that is applicable toward any of our other small group tours departing within 12 months from the date of cancellation. Cancellations must be made in writing to sierra@creativeedgetravel.com and are not official until the Founder, Sierra Busch, has acknowledged the cancellation. All cancellations after the 48-hour window automatically incur an administration fee of \$250. If you do not apply your credit to another tour departing within 12 months from your date of cancellation, your credit is then forfeit. If you DO apply your credit to another tour departing within 12 months of your date of cancellation, and you later cancel for a second time, you forfeit credit.

- A. Cancel within 48 hours of initial deposit: Full cash refund of deposit.
- B. **Cancel 90 days or more before departure:** Amounts paid will become credit that can be applied towards another small group trip departing within 12 months from the date of cancellation.
- C. Cancel 89 days or less before departure: No refunds, no trip credit, and no date changes will be granted.
- D. Cancellations Made at or During Trip: No refunds, no credit.
- E. No Shows: No refunds, no credit.

At the time of cancellation, if we have already made unrecoverable payments on your behalf for things like trains, entrance tickets, non-refundable deposits, etc, those costs will be deducted from your credit, if applicable. If the total unrecoverable costs exceed amounts paid, we will invoice you for the difference.

12. Minimum group numbers

CET Tours are subject to minimum numbers which vary per tour. Every endeavor is made to ensure the tours take place but if the minimum number of clients is not

reached, the tour may be canceled up to ninety (90) days before departure. In doing so, you will have the option to convert the trip to a private departure (additional costs may occur), convert amounts paid to credit applicable to any small group tour departing within 12 months, or get a full cash refund.

13. Discretion of group members

CET reserves the right to decline to accept or retain any person as a member of the tour at its own reasonable discretion.

14. Transferring your booking to another person

If you wish to transfer your Tour to another person (Assign), you must notify us at least 90 days prior to the proposed departure date, and the person must comply, must be approved by Us, and must agree with this Agreement as well as sign the Liability Waiver. An administration fee of \$250 USD per person per change will apply (in addition to any charges levied by any of our partners that are providing services as a part of your tour). Transferring your Tour to another person less than 30 days prior to the departure date is not permitted, nor will you be refunded in whole or in part.

15. Accommodations

Creative Edge Travel's small group tours are sold as shared rooms or single rooms. This means you will either share your room with one other participant or have a private room just for you, which has an additional cost. In order to reserve a private room, you should select Single Room at checkout. You should be aware that hotel room sizes, standard practices, and facilities can vary in each destination and can be different from standards in the United States or your home country. For example, variations could include differences in bed sizes, proximity of the beds to one another, and amenities such as air conditioning. CET hopes that you can enthusiastically embrace any differences you come across with the understanding that variations from culture to culture is what makes travel so fun and interesting.

If opting to share a room, you acknowledge that while we make our best effort to match you with a compatible roommate, we cannot guarantee that you will get along. If you're a light sleeper, get easily irritated, or know that you are someone who is much happier with your own space, sharing a room may not be the best decision for getting the most out of this experience. In the same way, if people have told you that you snore or you have health conditions that could be disruptive to others, we ask you to do the right thing and get a private room out of respect for others.

If you've made an honest effort but you absolutely can't find your groove with your roommate to the point that you really need to separate, your trip leader will make their best effort to move things around, or, try to get you a private room for an additional cost.

If the number of solo travelers and rooms doesn't allow CET to match you with a roommate, your room will become a single room and additional charges may apply.

16. Flexibility

You understand and acknowledge that the nature of your CET Tour requires considerable flexibility and you agree to allow for alternatives. The itinerary provided for each Tour is representative of the types of activities contemplated, but it is understood that the route, schedules, itineraries, amenities and mode of transport may be subject to alteration without prior notice due to local circumstances or events, and that you will not be entitled to refunds in part or in whole under such circumstances.

A. Technology and Communication Limitations

You acknowledge that WiFi, internet access, and cellular service may be limited, unreliable, or unavailable during portions of your tour, particularly in remote locations or certain international destinations. CET makes no guarantees regarding availability or quality of internet or phone services. Additionally, itinerary changes, transportation delays, or location modifications may affect your ability to communicate with home according to any predetermined schedule you may have arranged. You are responsible for informing family and emergency contacts of potential communication limitations and establishing alternative communication plans as needed.

17. Material Changes to your CET Tour Itinerary

While we endeavor to operate all trips as described we reserve the right to change the Tour itinerary without liability. If any of the hotels noted or pictured in your itinerary are not available at the time of booking and a change becomes necessary, we will make every effort to ensure the substituted accommodation will be equivalent in standard. Please refer to materials provided before departure by email for the most recent updates to your itinerary.

A. **Material Change before departure:** If we make a material change we will inform you as soon as reasonably possible if there is time before departure. The definition of a Material Change is deemed to be a change substantially affecting at least 48 hours during the Tour.

- i. When a Material Change is made you may choose between
 - 1. accepting the change as-is if the change does not increase the cost of your Tour; or
 - 2. Paying any applicable difference in increase for the cost of your Tour if such increase is needed within reasonable time under the circumstances to facilitate your continued participation on the tour; or
 - 3. You may apply the full cost you paid for your CET Tour as a credit toward a future CET Tour to be used within 12 months from the date of departure. Beyond 12 months, your credit cash value will diminish by 20% for each additional month that the credit is not applied.
- ii. A change of accommodation, restaurant /food, or transportation provider is not considered a Material Change.
- B. Material Change after departure: We reserve the right to change an itinerary after departure due to local circumstances or events outside of our control. In such emergency circumstances you agree that the additional cost of any necessary itinerary alterations will be covered exclusively by you. Please note we are not liable or responsible in any way for any expenses (incidental or non-incidental) that may be incurred as a result of a material change of itinerary after departure such as accommodations, visas, vaccinations or non-refundable flights, or your inability to continue participation in the Tour, or any need to return to your Home under such circumstances.
- C. Weather and Seasonal Activity Changes: You acknowledge that weather conditions, seasonal variations, and natural circumstances may require modifications to planned activities, excursions, or outdoor experiences. CET reserves the right to substitute alternative activities (which may include indoor alternatives) when weather or seasonal conditions make original planned activities unsafe, impossible, or inadvisable. Such weather-related substitutions are not considered Material Changes under Section 17A, and no refunds, credits, or compensation will be provided for activities modified due to weather, seasonal conditions, or natural circumstances beyond CET's control.

18. Authority on tour

CET Tours are lead by a Tour Leader. The decision of the Tour Leader is final on all matters likely to affect the safety or well-being of any CET client or staff member participating in the Tour. If you fail to comply with a decision made by a Tour Leader, or interfere with the well-being or mobility or safety of the group or any individual client participating in the Tour, we may terminate your participation in the Tour, and the Tour Leader may instruct you to leave the Tour immediately, with no right of refund in whole or in part. We may also elect not to carry you on any future trips booked. You must at all times comply with the laws, customs, foreign exchange and drug regulations of all countries visited, and you also agree to act responsibly and respectfully during the Tour. Failure to comply with laws or customs in any region during the Tour, or should you get arrested or detained by government authorities during the Tour gives CET the ability to immediately terminate your participation in the Tour, and the Tour Leader may instruct you to leave or not return to the Tour immediately, with no right of refund in whole or in part.

A. Group Cohesion and Dynamics

CET strives to maintain a positive group environment for all participants. We reserve the right to make reasonable adjustments to accommodate personality conflicts or behaviors that, while not grounds for removal, may negatively affect other participants' enjoyment of the tour. This may include relocating participants, adjusting room assignments, or modifying group arrangements as deemed necessary by the Tour Leader.

19. Assumption of risk

- A. You acknowledge that the nature of a CET Tour and all Tour activities are adventurous and participation involves degrees of personal risk of injury to your person and property.
- B. Your Tour may or may not involve visiting places where the political, cultural and/or geographical attributes present dangers and physical challenges greater than those present in our daily lives.
- C. You also acknowledge that any activity offered during your CET Tour comes with risks to your person and property that you fully assume and all risk and liability for.

- D. It is your responsibility to acquaint yourself with all relevant travel information and the nature of your Tour booking Confirmations. You acknowledge that your decision to attend and participate on the Tour is made in light of consideration of this information and that you accept and assume 100% of all risks to your person and property without liability of any kind to CET.
- E. CET also makes no warranty whatsoever that any other participant attending the Tour will be safe. CET does not provide background checks of any participants beyond verifying their age and validity of passport. CET makes no warranty of safety regarding the mental or physical safeness of any other client participant on the Tour and you fully understand and assume the risk of participating on the Tour with persons whose backgrounds have not been verified.

20. Travelers Who Require Special Assistance

The Americans with Disabilities Act ("ADA") is only applicable within the United States, and facilities for disabled individuals are limited outside its borders. A qualified and physically able companion must accompany travelers with disability who need assistance. Motorized scooters may be unsuitable for many trips. Transportation services, including many tour motor coaches, may not be equipped with wheelchair ramps. Hotels may have accessible rooms. We do not, however, guarantee that all hotel facilities are accessible for travelers with disabilities.

We will take reasonable measures to cater for any special requirements a disabled traveler may have. If you or any member of your party has any medical problem or disability which may affect your trip, please provide us with full details before we confirm your booking so that we can try to advise you as to the suitability of your chosen arrangements. We may require you to produce a doctor's certificate certifying that you are fit to participate in the trip. If we are unable to properly accommodate the needs of the person(s) concerned, we will not confirm your booking or if you did not give us full details at the time of booking, we may cancel it and impose applicable cancellation charges when we become aware of these details.

21. Limitation of Liability

CET's total liability to you for any and all claims, damages, losses, and causes of action (whether in contract, tort, or otherwise) arising out of or relating to your tour, these terms and conditions, or CET's services shall not exceed the total amount paid by you to CET for the specific tour in question. In no event shall CET be liable for any indirect, incidental, special, consequential, or punitive damages, including but not limited to loss of profits, loss of enjoyment, or emotional distress, even if CET has been advised of the possibility of such damages.

22. Personal Property and Belongings

You are solely responsible for your personal belongings, luggage, and valuables at all times during the tour. CET assumes no responsibility or liability for any lost, stolen, damaged, or delayed personal property, including but not limited to luggage, electronics, jewelry, documents, or other personal items, regardless of the cause. This includes property left in hotel rooms, transport vehicles, restaurants, or any other locations during the tour. We strongly recommend you verify that your personal homeowner's, renter's, or travel insurance provides adequate coverage for personal property while traveling, as CET's insurance does not cover clients' personal belongings.

23. Complaints

We make every effort to ensure that your arrangements run smoothly, but if you do have a problem during your trip, please inform your Tour Leader immediately, who will endeavor to solve the problem. If your complaint is not resolved locally, please contact us on +1 (706) 889-1539. If the problem cannot be resolved and you wish to complain further, you must send formal written notice of your complaint to us by e-mail sierra@creativeedgetravel.com within 28 days of the end of your trip, giving your booking reference and all other relevant information. Please keep your letter concise and to the point. This will assist us to quickly identify your concerns and speed up our response to you. Failure to follow the procedure set out in this clause may affect ours and the applicable supplier's ability to investigate your complaint.

24. Credit Card Chargebacks

Before initiating a chargeback related to any supplier of service, you agree to first attempt to resolve directly any disputed transaction fees with us. You agree to indemnify, hold harmless and defend CET against debit memos for credit card chargebacks arising out of: (a) your complaints regarding any service or (b) unauthorized charges by members of your family or former employees of your company. You also agree to refrain from initiating a chargeback dispute for any other reason except fraud. You further agree to pay CET's reasonable attorney fees and expenses if CET has to file suit against you in order to enforce the indemnification provision under this Section 14 of the Agreement or if you initiate a chargeback dispute arising out of a cause other than fraud.

25. Severability

In the event that any term or condition contained in this agreement is unenforceable or void by law or against public policy or for any other reason then such term or condition shall be deemed severed from this contract or amended accordingly only to such extent necessary to allow all other remaining terms and conditions to survive and continue as binding. No modification, amendment, or waiver of any provision of this Agreement shall be effective unless made in writing and signed by both parties. Any verbal agreements or understandings are not binding.

26. Indemnification

I agree I will defend, indemnify, and hold harmless CET, CET Staff, and any CET 3rd Party Affiliate Provider from and against any claim, demand, loss, injuries or other causes of action arising out of any damage I cause (whether alone or with others) from any act, omission, violation, or misrepresentation I may make.

27. Photos and marketing

You consent to us using images of you taken during the trip for advertising and promotional purposes in any medium we choose. You grant us a perpetual, royalty-free, worldwide, irrevocable license to use such images for publicity and promotional purposes.

28. Privacy

Any personal information that we collect about you may be used for any reasonable purpose associated with the execution and operation of our Tour or to send you marketing material in relation to our events and special offers. The information may be disclosed to our agents, service providers or other suppliers to the extent necessary to enable us to operate the Tour and your Participation in it.

29. Headings

The headings of the various sections of this Agreement have been inserted for convenience of reference only.

30. Relationship of the Parties:

Nothing contained herein shall imply any partnership, joint venture or agency relationship between the Parties and neither Party shall have the power to obligate or bind the other in any manner whatsoever, except to the extent herein provided. The parties have solely and exclusively engaged herein as independent contractors.

31. Force Majeure:

"Force Majeure" means, in relation to CET, any circumstances beyond the reasonable control of CET, (including, but without limitation, acts of God, explosion, flood, tempest, forceful wind, fire or accident, war or threat of war declared or undeclared, acts of terrorism, sabotage, insurrection, riots, strikes, civil disturbance, requisition, sickness, quarantine, government intervention, weather conditions, defects in machinery and vehicles, delay, wildlife, or other untoward occurrences).

CET shall not be deemed to be in breach of these Terms and Conditions or otherwise be liable to you, by reason of delay in performance, or by non-performance, of any of its obligations hereunder to the extent that any such delay or non-performance is due to any Force Majeure.

If CET, and/or any of its' travel suppliers, are affected by Force Majeure, they shall be entitled to, and may in their sole and absolute discretion, vary or cancel any itinerary or arrangement in relation to your trip. Payment of any refund by CET to you as a result of the non-performance of any obligations hereunder shall remain in its sole and absolute discretion, although CET shall use its reasonable efforts to reimburse you where possible. However, CET shall be entitled to deduct from any refund recoverable the reasonable actual and potential costs to CET of the Force Majeure and applicable cancellation fees.

Regarding civil unrest, once CET has investigated the prevailing situation, as it deems fit, it shall remain in CET's sole and absolute discretion whether to proceed with your trip. You may in such circumstances cancel the trip subject to CET's and each supplier's terms and conditions.

32. Coronavirus Pandemic

As the worldwide COVID-19 coronavirus pandemic remains ongoing at this time, you acknowledge that for this reason, and other reasons not reasonably foreseeable at this time, your travel plans may be interrupted or cancelled by the supplier that is providing them, a government entity or other third party over which we have no control. You further acknowledge that the suppliers' own cancellation, rebooking and refund policies, subject to any applicable law that is now or may later be in effect, will govern your rights and remedies, including your right to receive a refund, in such an event. Moreover, you understand that should you elect to purchase travel insurance, the terms of the policy will dictate whether, and to what extent, coverage for any financial loss may exist under the circumstances. You acknowledge that CET has no special knowledge of health hazards such as the risk of contracting Covid-19 or any other disease, either during the client's travel or at the client's destination. For the latest travel health information, the client should review the State Department's website at travel.state.gov and the CDC's information at www.cdc.gov/travel. CET has no responsibility for Covid-19-related requirements that travel suppliers and governments may impose from time to time, such as health affidavit forms, health screenings prior to departure or upon arrival, face coverings, or quarantines. For the latest Covid-19 government travel regulations, the client should review IATA's website at www.iatatravelcentre.com. For the latest travel supplier requirements, check the supplier's homepage.
